## Regarding the Acquisition of Shares in Mitsui & Co. Agri Foods Ltd.

We are pleased to announce that our company has entered into a share transfer agreement with Mitsui & Co., Ltd. (Headquarters: Chiyoda-ku, Tokyo, President: Kenichi Hori, hereinafter referred to as "Mitsui") to acquire all shares of Mitsui & Co. Agri Foods Ltd. (Headquarters: Minato-ku, Tokyo, President: Keiichi Tsukahara, hereinafter referred to as "Mitsui & Co. Agri Foods"), a subsidiary of Mitsui.
